This environment demands approaches far more sophisticated and integrated than those employed during the Cold War. The challenges posed by technological disruption, information warfare, and economic coercion cannot be met by governments alone. Collaboration across public and private sectors, combined with insights from academia, is essential to develop innovative, well-coordinated strategies capable of addressing these multifaceted challenges.

With that in mind, we recognize that our current operating environment reflects a paradigm shift in how strategic competition unfolds—moving beyond conventional warfare to persistent, multidomain challenges that demand agility, integration, and sustained engagement. As highlighted in the US Joint Concept for Competing (JCC), today's adversaries seek to "win without fighting" by leveraging cyber intrusions, economic coercion, legal warfare, and influence operations to bypass traditional deterrence and reshape global balances of power [1]. For instance, state actors increasingly use cyber operations to undermine infrastructure, weaponize global supply chains, and employ disinformation campaigns to destabilize governance in contested regions.

The Joint Doctrine Note 1-19, Competition Continuum reinforces this complexity, framing competition as a fluid continuum spanning cooperation, competition below armed conflict, and armed conflict [2]. Success in this dynamic environment requires states to engage proactively across all levels—shaping the competitive space, countering adversarial actions, and leveraging innovation to exploit vulnerabilities before they escalate. Building on this, Joint Doctrine Note 1-22, Joint Force in Strategic Competition underscores the protracted nature of modern competition, where outcomes are determined not by single decisive victories but through persistent influence and careful shaping of the environment over time [3].

Central to this effort is the application of strategic art: a deliberate and cognitive approach that aligns objectives, outcomes, and actions to secure sustained advantage. Strategic art calls for proactive, integrated strategies that deter escalation while countering adversarial moves across domains. The Joint Concept for Integrated Campaigning further emphasizes the importance of multi-domain responses, advocating for unity of efforts across national, international, and interagency lines to align military operations with diplomatic, economic, legal, and informational tools of power [4]. This kind of coordination ensures that competition is not merely reactive but deliberately shaped to deny adversaries opportunities while advancing strategic aims.

By recognizing the enduring and multidimensional nature of strategic competition, the imperative becomes clear: success requires the ability to adapt, integrate, and innovate responses across all instruments of power. As rapid advancements in artificial intelligence, cyber capabilities, and global economic interdependencies reshape competition, states must remain agile and forward-thinking. The challenges posed by influence operations in Eastern Europe, technological and economical advancements in the Indo-Pacific, and the weaponization of supply chains underscore the need for comprehensive approaches

grounded in actionable insights and deliberate strategy.
